**Invitation to Bid for**

***Construction of Multi-Purpose Building at San Isidro,  
Babak District, IGaCoS under PR# 2019-05-2342.***

The ***Local Government Unit of the Island Garden City of Samal***, through the ***20% Dev't. Fund CY 2019*** intends to apply the sum of ***Nine Hundred Fifty Three Thousand Thirty Seven Pesos and Ninety Eight Centavos (Php 953,037.98)*** being the Approved Budget for the Contract (ABC) to payments under the contract for ***Construction of Multi-Purpose Building at San Isidro, Babak District, IGaCoS under PR# 2019-05-2342***. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The ***Local Government Unit of the Island Garden City of Samal*** now invites bids for ***Construction of Multi-Purpose Building at San Isidro, Babak District, IGaCoS under PR# 2019-05-2342***. Completion of the Works is required ***Seventy Five (75) Calendar Days***. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in ***Error! Reference source not found.***

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from ***BAC Secretariat, BAC Office, City Hall Compound, Peñaplata, IGaCoS*** and inspect the Bidding Documents at the address given below from ***July 9-29, 2019***.

A complete set of Bidding Documents may be acquired by interested bidders on ***July 9, 2019*** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of ***One Thousand Pesos (P1, 000.00)***.

The LGU-IGaCoS will hold a Pre-Bid Conference on ***July 16, 2019 1:00PM*** at ***BAC Conference Room, BAC Office, City Hall Compound, Peñaplata, IGaCoS***, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before *12:00 noon of July 29, 2109* at *BAC Office, City Hall Compound, Peñaplata, IGaCoS*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on *July 19, 2019 at exactly 1:00p.m.* at *BAC Conference Room, BAC Office, City Hall Compound, Peñaplata, IGaCoS*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Local Government Unit of the Island Garden City of Samal* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
