AN ORDER LIFTING EXECUTIVE ORDER NO. 60 ISSUED ON JANUARY 6, 2017 ENTITLED "MORATORIUM ON THE IMPLEMENTATION OF ADMINISTRATIVE FINES AND PENALTIES UNDER SECTION 51, CITY ORDINANCE NO. 2009-150 FOR THE CONSTRUCTION OF JETTIES AND OTHER PROHIBITED STRUCTURES WITHIN THE EASEMENT, SHORELINE AND OTHER PROHIBITED AREAS".

WHEREAS, Executive Order No. 60 was issued on Jan 06, 2017 in support to the BUSINESS ONE STOP SHOP (BOSS) of Island Garden City of Samal for fiscal year 2017. The order declared a Moratorium on the Implementation of Administrative Fines and Penalties under Section 51, City Ordinance No. 2009-150 for the Construction of Jetties and other Prohibited Structures within the Easement, shoreline and other Prohibited Areas";

WHEREAS, by virtue of the said Executive Order, the collection for unpaid obligations (Administrative Fines and Penalties) incurred prior 2017 was suspended and deferred temporarily;

WHEREAS, pursuant to the review powers of the Governor under Section 30, RA 7160, in his letter dated March 21, 2017, the Vice Governor (Acting Governor), Alan R. Dujali, upon the recommendation of the Provincial Legal Office, opined that since such fines and penalties were imposed by virtue of an ordinance, therefore, the suspension and deferment shall also be through an ordinance;


WHEREAS, by virtue of the said recommendation, the undersigned City Mayor of Island Garden City of Samal declared that the moratorium on the implementation of Administrative Fines and Penalties under Section 51 of City Ordinance No. 2009-150 is lifted effective August 30, 2017 until an amendment to City Ordinance No. 2009-150 giving effect to the moratorium will be in-placed by the Sanguniang Panlungsod of Island Garden City of Samal;

WHEREAS, pending amendments of the Code, the undersigned is mandated to enforce the provisions of Section 51 of this Code effective August 29, 2017;

NOW THEREFORE, I, AL DAVID T. UY, City Mayor of the Island Garden City of Samal, by virtue of the powers vested in me by law, do hereby order the **LIFTING** of Executive Order No. 60, Series of 2017 and the operation of Section 51 of City Ordinance No. 2009-150 is hereby restored.

Effective immediately.
