EXECUTIVE ORDER NO. 89

“AN ORDER DESIGNATING A CITY YOUTH DEVELOPMENT OFFICER IN THE LOCAL GOVERNMENT UNIT OF THE ISLAND GARDEN CITY OF SAMAL, PROVINCE OF DAVAO DEL NORTE, PHILIPPINES”

“**WHEREAS**, Republic Act No. 10742, otherwise known as the Sangguniang Kabataan (SK) Reform Act of 2015 and its implementing Rules and Regulations, provides for the creation of a Youth Development Office in every province, city and municipality;

WHEREAS, Department of the Interior and Local Government (DILG) Memorandum Circular No. 2017-36 dated February 24, 2017 mandates all Provincial Governors, City and Municipal Mayors to create their respective Local Youth Development Office (LYDO) within their areas of jurisdiction;

WHEREAS, with the limitations on personnel services, a Youth Development officer shall be designated in order to serve the purpose and shall be under the Office of the City Mayor;

NOW, THEREFOR, I, AL DAVID T. UY, City Mayor of the Island Garden City of Samal, Davao del Norte, by virtue of the powers vested upon me by law, do hereby designate **MR. JOMAR VON D. BATUCAN**, Administrative Assistant V, as **CITY YOUTH DEVELOPMENT OFFICER** of the Local Government unit of the Island Garden City of Samal with the following functions:

Section 1. Duties and Responsibilities. The City Youth Development Officer shall perform the following duties and responsibilities:

1. Register and verify youth and youth-serving organizations (Subject to the revitalized Youth Organizations Registration Program (YORP) guidelines) in accordance with Section 24 (d) of Republic Act No. 10742;
2. Provide technical assistance to the Local Youth Development Council (LYDC) in the formulation of Local Youth Development Plan;
3. Facilitate the election of the LYDC representatives;
4. Serve as Secretariat to LYDC;
5. Conduct mandatory and continuing training of SK officials and LYDC members, in accordance with the programs jointly designed and implemented by the National Youth Commission (NYC) and DILG;
6. Provide technical, logistical and other support in the conduct of mandatory and continuing trainings, programs and such other programs of NYC and DILG;
7. Coordinate with the Commission, with regard to the youth programs within your jurisdiction;
8. Collaborate with the concerned Provincial YDO for the implementation of certain provision of Republic Act No. 10742;
9. Collaborate with the concerned DILG Field Officer and LGU officials in the conduct of SK Mandatory Training;
10. Submit accomplishment report on the conduct of SK Mandatory training to NYC; and,
11. Perform such other functions as may be prescribed by law, ordinance, or as LCE, the DILG or the NYC may require.

SECTION 2. Effectivity. This Order shall take effect immediately upon approval thereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief Executive.
