**Invitation to Bid for**

***Procurement of One Unit Brand New 4x2 Vacuum Truck (Dislogder/Fecal Suction) under PR No. 2019-02-1402***

The *Local Government Unit of the Island Garden City of Samal*, through the *General Fund CY 2018* intends to apply the sum of *Eight Million Pesos (₱8,000,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of One Unit Brand New 4x2 Vacuum Truck (Dislodger/fecal Suction) under PR No. 2019-02-1402*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *Local Government Unit of the Island Garden City of Samal* now invites bids for *Procurement of One Unit Brand New 4x2 Vacuum Truck (Dislodger/fecal Suction) under PR No. 2019-02-1402*. Completion of the Works is required *One Hundred Twenty Calendar Days (120CD)*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from *Bids and Awards Committee Secretariat* and inspect the Bidding Documents at the address given below from *9:00am to 5:00pm*.

A complete set of Bidding Documents may be acquired by interested bidders on *March 6, 2019* from the address below during office hours upon payment of non-refundable fee of Twenty Five Thousand Pesos only (₱10,000.00).

The *Local Government Unit of the Island Garden City of Samal thru the Bids and Awards Committee* will hold a Pre-Bid Conference on *March 13, 2019 1 o'clock in the afternoon* at *BAC Conference Room, CGSO Bldg, City Hall Compound, Peñaplata, IGaCoS* which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before *12 noon of March 25, 2019*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *March 25, 2019 1 o'clock in the afternoon BAC Conference Room, CGSO Bldg, City Hall Compound, Peñaplata, IGaCoS*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Local Government Unit of the Island Garden City of Samal* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
